Mr. Rhodes: The Sheriff has informed him that he would like to move forward with the renovations to his office. It was talked about previously and approved, but he doesn't feel it will happen in 2025. He will look into how it was funded in 2025 and what needs to be done to fund it in 2026.

Mr. Wells: The AATV meeting is this week. He asked Mr. Rhodes if this renovation is the large project that has been talked about. Mr. Rhodes stated no, just a reorganization of the Sheriff's Office. He now has his new deputy back from training and he is interviewing for an Account Clerk; the office needs to be made more efficient.

Ms. Bain: The Village Mayor contacted her regarding meeting with the County Board to explain why the Village would like to buy the old Peter's Oil property in Speculator. The use would be for public parking and a park. She would like to meet with the County Board to educate us on the pros and cons and they are willing to put in the deed any restrictions that the County wants for no buildings. The Chairman asked if the County owns that property. Mr. Baker explained that the DEC has a lien on the property. The County has old tax liens on the property that we made the Village whole for that the County is in debt to collect. There have been discussions regarding this

in the past. It was never foreclosed on. It was removed from the tax roll. It is still owned by Peter's Oil. The Board discussed the history of the property further. Ms. Bain will reach out to the Mayor to set up a time for a meeting.

WHEREAS, the Public Works Committee has reviewed the proposal and supports the project, now, therefore, be it

Other Board members stated that they had heard the same thing and witnessed it. Mr. Fernandez stated that possibly they need more training and put the visors back up so when you are at the voting machine you are by yourself. The Board discussed the fact that more privacy is needed.

> LOCAL LAW NO. 7 OF 2025 State of New York County of Hamilton

A LOCAL LAW OVERRIDING THE TAX LEVY LIMIT FOR HAMILTON COUNTY FOR 2026 AND AUTHORIZING THE ADOPTION BY HAMILTON COUNTY OF A BUDGET FOR 2026 THAT WILL REQUIRE A TAX LEVY THAT IS GREATER THAN THE TAX LEVY LIMIT FOR THE 2026 FISCAL YEAR

BE IT ENACTED, by the Board of Supervisors of the County of Hamilton as follows:

- Section 1. Title: This Local Law shall be known as "Hamilton County Responsible Budgeting Law of 2026".
- Section 2. Declaration of intent: The intention of this local law is to comply with the requirements of General Municipal Law Section 3-c (5) prior to adopting the 2026 Hamilton County Budget. The combined impact of persistent inflation, workforce and supply shortages have necessitated this increase. Notwithstanding current

economic and fiscal conditions, the County will need to provide services in 2026, in addition to those mandated by the State, which are important to our citizens. After serious and sustained efforts to minimize the amount of the tax levy, it is clear that a responsible 2026 Hamilton County Budget will require a tax levy that will be greater than the tax levy limit calculated pursuant to applicable State Law.

- Authorization: This local law is adopted pursuant to subdivision 5 of General Municipal Law Section 3-c, which expressly authorizes the Hamilton County Board of Supervisors to override the tax levy limit by the adoption of a local law approved by a vote of sixty percent (60%) of the Board of Supervisors. This local law hereby authorizes adoption of a 2026 fiscal year budget for Hamilton County that requires a tax levy increase that is greater than the calculated tax levy limit.
- Section 4. Severability: If any section, subsection, sentence, clause, phrase or other portion of this local law is for any reason declared unconstitutional, or invalid or in whole or in part by any court of competent jurisdiction, such portion shall be deemed severable and such unconstitutionality or invalidation shall not affect the validity of the remaining portions of this law which remaining portions shall remain in full force and effect.
- Section 5. Effective Date: This local law shall take effect upon the date on which a certified copy of this local law is filed in the office of the Secretary of State pursuant to section 27 of the Municipal Home Rule Law.
