### SEVENTH ANNUAL SESSION

### **DECEMBER 18, 2025**

The Board convened at 10:30 A.M. in the Supervisors' Chambers at the Court House, Lake Pleasant, New York, with the Chairman, Clay J. Arsenault presiding. Mr. Arsenault led the members of the Board of Supervisors in the Pledge of Allegiance to the Flag, and an opening prayer.

Reports of Standing/Special Committees:

Mr. Rhodes: There is a resolution on the agenda today to authorize going out to bid for the Arietta and Morehouse towers. Mr. Rhodes discussed changing wording in the resolution so that the project is contingent on the grant being extended, not going out to bid. They are continuing to work on the utility easements for both tower sites. Yesterday they received the signed easement agreement for the Arietta site, but the Morehouse site is being delayed by a request from the owner's attorney. DANC is still researching options for additional funding, they have a meeting at the end of the month so hopefully we will have an update in the start of the new year. There has been no progress on the agreement with the IDA and Oak Mt. regarding the cabins, specifically the quantity that is to be available to the County.

Mr. Snyder: There are two resolutions for the Central Government Committee on the agenda for your consideration.

Ms. Hunt: The Treasurer's Office has been working on the Board Room, hallway, and Treasurer's Office renovation. They have met with CPL Architecture Firm. Mr. Eldridge explained that they

have the bid documents and they should be able to go to bid in January. Ms. Hunt further explained that she will be presenting two resolutions at the end of the meeting, one for the Treasurer's Office and one for Public Health.

Mr. Tomlinson: There are a few resolutions on the agenda for Public Works.

The Chairman introduced Caitlin Stewart, District Manager, Hamilton County Soil & Water District.

Ms. Stewart gave an Autumn Update for the Hamilton County Soil & Water District. Ms. Stewart explained that Lenny Croote, District Senior Technician and Katie WhitKovits, Technician, are with her today. Ms. Stewart reviewed the handout she had given the Board regarding the Hazard Mitigation Plan grant, the Septic System Replacement Fund and the 46<sup>th</sup> Annual Conservation Field Day. Ms. Stewart discussed the Septic System Replacement Fund Grant Awards by town breakdown, that was also handed out. There is not a date for the release of Round 5 for the Septic System Replacement Fund, but if the County would like them to, they are willing to administer Round 5. The current Hazard Mitigation Plan expires in October 2026. The purpose of the plan is to effectively reduce future disaster damages, public expenditures, private losses, and community vulnerability to natural disasters, technology, and manmade hazards. The Plan is used for preference points on DEC grant applications. The grant funds they are applying for will support hiring a consultant to develop the plan. Ms. WhitKovits gave an update on the 46<sup>th</sup> Annual Conservation Field Day event. Ms. Stewart thanked Ms. Bain and Ms. Hunt for serving as Directors on their Board and the Board of Supervisors for their support. At this time Ms. Stewart showed a video regarding the Shaw Brook restoration.

The Hamilton County Soil & Water District team left at this time.

### PROPOSED LOCAL LAW NO. 1 OF THE YEAR 2026

# A LOCAL LAW TO PROVIDE INCREASES IN THE COMPENSATION OF CERTAIN COUNTY OFFICERS

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

SECTION 1. As per Section 201 of County Law, the Board of Supervisors can only increase the salary of a county officer who is elected for a fixed term or appointed for a fixed term, in the middle of that term of office, if Section 24 (2)(h) of the Municipal Home Rule Law is complied with. In keeping with that compliance, Local Law No. 1 of 2026 is hereby enacted setting the annual salaries for the year 2026 for the following county officers who are elected or appointed for a fixed term, and whose terms did not expire on December 31, 2025.

These salaries shall be effective as of January 1, 2026.

SECTION 2. This Local Law shall take effect forty-five (45) days from the date of adoption by the Board of Supervisors unless a petition is filed in accordance with Municipal Home Rule law, and after filing with the Secretary of State. All Department Head salary changes will be implemented uniformly after such filing.
